**New Court Fees, Fee Increases  
Effective January 1, 2004**

(Oakland)—The Superior Court of California, County of Alameda announces new court filing fees and fee increases, as the result of Assembly Bill 296 (*approved by the Governor on October 10, 2003*) and Senate Bill 1732 (*statutes of 2002-2003*).

Fees charged and collected by California's trial courts are composed of base statewide fees and surcharges and applicable local fees. A list of the Alameda County fees that are impacted by these changes is attached to this press release. ## NOTICE OF FEE INCREASES (Effective 1-1-2004)

Assembly Bill 296 revised fees and established the additional security surcharge on specified civil cases. SB 1732 established surcharges that are deposited into the State Court Facilities Construction Fund. The surcharges are increased from \$10 to \$15 for certain unlimited jurisdiction civil, probate, and family law actions. Please find the impact of AB 296 and SB 1732 on our local fees below.
