# 1. Page 1, Proposal Due

#### 2. Page 3, Section 2.2 Service Requirement.

 Removed: "The Court Anticipates the Contractor will provide a two hour maximum Help Desk time from the initial service request"

#### 3. Page 3, Section 2.2 A Service Requirement

Replaced: "4 to 6 hours" with "within the next business day"

# 4. Page 3, Section 2.2 C Service Requirement

 Removed: "Contractor must maintain a First Response "on site" repair rate of 80% or higher"

# 5. Page 3, Section 2.3 Preventative Maintenance Service

• Included: "On an as needed basis"

### 6. Page 4, Section 2.3 C: Preventative Maintenance Services

 Removed: "Contractor to provide all parts and supplies, including but not limited to glass, bulbs, rollers and maintenance kits shall be included as part of the Agreement and furnished at no additional charge. This includes replacement for any supplies or parts that may be caused by operator neglect"

#### 7. Page 4, Section 2.3 D: Preventative Maintenance Services

• Removed: "Unlimited", "and maintenance kits shall be included"

#### 8. Page 4, Section 2.4 Equipment Maintenance Service

 Removed: "Emergency service required and performed during normal business hours is included at no extra charge"

## 9. Page 4, Section 2.5 Equipment Maintenance Service-Shop Work

Removed: "Included in this agreement at no extra charge. A comparable piece
of equipment will be loaned, when required, at no extra charge"

#### 10. Page 4, Section 2.6 Equipment Maintenance Service – Parts

 Removed: "Any parts other than those manufactured by the original equipment manufacturer shall be approved by the Court before being incorporated in the work performed by the contractor under this Agreement"

# 11. Page 4, Section 2.6 Equipment Maintenance Service – Parts

Removed: "All parts will be provided to the Court at no additional charge"

#### 12. Page 4, Section 2.7 Equipment maintenance service standard

Removed: "The Contractor further agrees that all components will be OEM
components. At the termination of the Agreement the Contractor guarantees
that equipment will meet OEM equipment certification standards."

Removed: "Monthly"

#### 14. Page 7, Section 5.6 Payment Information

Removed: "and the State does not make any advance payment for services"
